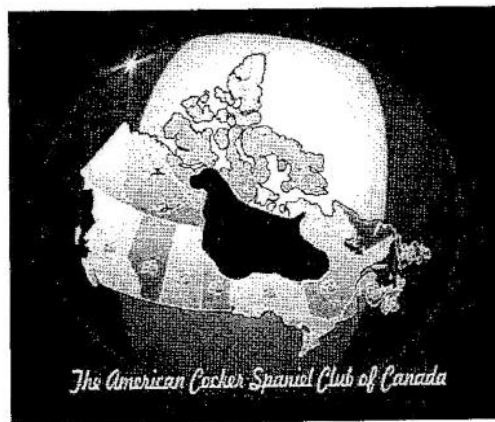

**CLASSES**

**Regular Classes:** Junior (6-9), Senior (9-12), 12-18 Month, Canadian Bred, Bred By Exhibitor, Open, Veterans, Best of Breed and Exhibition only  
**Non-Regular Classes:** Brace, Stud Dog, Brood Bitch, (Dogs must be entered also in the regular or exhibition only classes). Awards of Merit shall be awarded to the entries in Specials Only including the Veterans, based on 1 AOM offered for every 10 Specials entered.
